## **1.25** New Council formed Councillors signed the Declaration of Office

## 2.25 Election of Chairman

It was proposed, seconded, and resolved to nominate John Webb as the Chairman of the Council

John Webb signed the Declaration of Office

#### 3.25 Chairman's Welcome and Announcements

The Chairman welcomed everyone to the meeting

#### 4.25 Election of Vice-Chairman

It was proposed, seconded, and resolved to nominate Jonathan Hartnell-Beaves as Vice-Chairman of the Council

Jonathan Hartnell-Beavis signed the Declaration of Office

#### 5.25 Apologies

Apologies were received from Shropshire Councillor Elizabeth Barker (alternative meeting) and Jonathan Murnane (ill-health)

## 6.25 Disclosable Pecuniary Interests

There were no declarations of interest at this time

The Parish Clerk said that Shropshire Council was asking Parish Councillors to register their Pecuniary Interests online during this term of office. Instructions on how to do this would be circulated to all Councillors.

## 7.25 Power of General Competence

It was resolved to agree that the Parish Council is an eligible council to exercise the General Power of Competence in accordance with the Localism Act 2011 ss 1-8 as i) the Parish Clerk has holds CiLCA and ii) as two-thirds of the Councillors were elected and not co-opted

## 8.25 Co-Option

It was resolved to co-opt Anne Banks as a member of the Parish Council

Anne Banks signed the Declaration of Acceptance of Office

It was resolved to co-opt Jonathan Murnane as a member of the Parish Council

Jonathan Murnane was not able to attend the meeting. It was agreed that his Declaration of Acceptance of Office could be signed and witnessed as soon as possible outside of the meeting.

#### 9.25 Public Forum

The Parish Clerk said that a road closure sign was up at the entrance to road through Havenhill by Brockton, but no diversion signs were in place. Further signs on the road had said that the closure was for 28<sup>th</sup> May – no information had been sent by Shropshire Council about it. She said she would follow this up.

## 10.25 Shropshire Councillor's Report

Shropshire Councillor Elizabeth Barker was elected on 1<sup>st</sup> May 2025 to the newly formed Shifnal Rural division. She has contacted the Parish Clerk and has said she is intending to attend the next meeting but is unable to make this one as she has already agreed to attend another Parish Council meeting.
